# WHAT DOES NORTH COUNTY CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

# Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

#### What?

- · social security number and income
- · account balances and payment history
- · credit history and credit scores

When you are *no longer* our member, we continue to share your information as described in this notice.

### How?

All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons North County Credit Union chooses to share; and whether you can limit this sharing.

What we do	
How does North County Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does North County Credit Union collect my personal information?	<ul> <li>We collect your personal information, for example when you:</li> <li>open an account or deposit money</li> <li>pay your bills or apply for a loan</li> <li>seek advice about investments</li> <li>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</li> </ul>
Why can't I limit all sharing?	Federal law gives you the right to limit only

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies  • North County Credit Union has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies  • North County Credit Union does not share with nonaffiliates so they can market to you
Joint Marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include mortgage bankers, securities broker-dealers and insurance agents</li> </ul>

## Other important information

California law provides that a consumer has the right to control the sharing of personal and financial information with outside companies the financial institution contracts with to provide financial products and services. To exercise your right, refer to the separate notice titled, "Important Privacy Choices for Consumers" which is provided to you by North County Credit Union.
